The four County Council At-Large candidates have provided information so that you might make an informed choice. You will voting for three of the four candidates to represent you on the council as at-large members.

My name is Vicki Andrews and I am running for Wells County Council At-Large. I am currently serving my 7th year on the County Council. I am running for this position as I feel a strong desire to serve the community. I have lived in Wells County most of my life and on our family farm in southern Wells County. My parents Dean and Pat Mounsey were farmers for over 60 years and continue to own the family farm. I have 3 daughters and 7 grandchildren. The County Council is the financial body of the county and my experience working in banking, Wells County Clerk and Treasurer's offices, and corporation treasurer at Southern Wells Community Schools has given me much knowledge to use in the county position. These experiences have also given me much knowledge as to how the county government works and how to work with all people in the community. I am a member of Sonlight Wesleyan Church as well as a board member for Wells County Chamber of Commerce, Wells County Trails, Junior Achievement and the County Extension Board. I have a passion for people and I have found that Wells County has wonderful people.

I am Michael K. Mossburg, a 1983 graduate of Southern Wells High School, and I completed the Purdue Short Course in 1985. I have been married to Shelley (Oliver) Mossburg of Bluffton for 35 years and have two daughters: Chelsea Mossburg, a Purdue Graduate and Olivia Mossburg, an Indiana State Graduate. Both have returned to Wells County and are working locally.

I am currently serving as president of the Wells County Council, president of the Wells County Regional Sewer District, president of Tech Services, Inc, and president of Mossburg Enterprises, Inc. I own/operate Tech Services which employs 16 full-time staff and 40 seasonal workers. I am a member of the American Seed Trade Association, Indiana and Illinois Seed Trade Associations, Wells County Chamber of Commerce, Wells County Soil and Water Conservation, Wells County Comprehensive plan steering committee and Indiana Crop Improvement Association (ICIA). I have served as past president of ICIA as well as several other agricultural committees. I also own/operate a 1250 acre seed production and grain farming operation south of Liberty Center.

I have served on Council for the past 7+ years maintaining a strong fiscal position in the county and focusing on improving key departments in government. My past experience in operating my own service business has been very beneficial in reviewing county services and budgets.

As a Councilman, my goals will be to continue working with other council members on managing budgets. The focus in 2020 will be on capital projects which include a new highway garage, the north and south corridor projects, future zoning and affordable housing options, and new quality of life initiatives.

Successful economic development remains a top priority for me in Wells County government. I fully support and intend on maintaining a balanced county budget with strong rainy day reserve.

I am excited to announce my candidacy for re-election to Wells County Council, At Large. The people of Wells County make this a great place to live. Challenges that demand our attention will always exist. Today it is continuing to improve county roads, building a highway garage, jail upgrades, and rural sewer issues. Expanding high speed internet to additional areas of Wells County must continue and isa critical areas need. Each of these priorities must be balanced with a conservative property tax policy. My goal is to make Wells County the greatest place to live, work, and raise families.

It has been an honor and a pleasure to represent the Republican Party and serve citizens of Wells County. I look forward to continuing my work for the party and people of Wells County.



Scott Elzey grew up in Wells County. Except for work-related time in Atlanta, Houston, and Fort Wayne, he has resided here all his life. He has been married to his wife, Deanna, for 37 years. They have two grown children and one grandson. Scott graduated from Indiana University with a BS degree in business administration with a focus on marketing and psychology.
